Mary and her husband Chris own and operate Kraft Family Dairies with assistance from their son Stratton. Mary has served on the Morgan County Economic Development Corporation Board, the Fort Morgan Community Hospital Association Foundation Boards, the School for the Performing Arts and the Adult Basic Literacy Education Board. She recently completed her term as the first female President of the Colorado Livestock Association and serves on the Western Dairy Association's Milk Promotions Board and the PERA Advisory Council. Mary has written a variety of articles for leading dairy magazines and speaks extensively across the country to agriculture groups. She has had the opportunity to testify before legislation on good animal husbandry and immigration issues.

WHO CALP is a competitive two-year leadership program that develops and enhances the leadership capabilities of diverse men and women committed ARE to the future of Colorao's agricultural and rural communities.

WHAT WE ARE

Fellows attend 10 seminars with 41 days of intense training. They will hear over 135 speakers, work with current leaders in agriculture, attend on-site agricultural operation visits, receptions and discussions, produce the Governor's Ag Forum and enjoy a network of over 300 alumni. CALP Fellows travel around the state, to Washington D.C. and internationally to study agriculture issues, political processes, development of leadership skills, team building, fundraising and communications.

WHY WE ARE

CALP answers the call to create and nurture leadership skills of agricultural individuals through a hands-on, interactive program dedicated to producing graduates with the vision and commitment to lead change and ensure the sustainability of Colorado's agricultural economices and rural communities.

DEADLINE IS SEPT 1, 2020

Is there an age limit?

While CALP does not enforce an age limit, individuals should be in the early or middle phase of their leadership career and looking for that next level of training or experience.

What is the cost?

Each participant is required to provide \$3,500 tuition, either raised through fundraising or paid through personal channels.

Who should apply?

CALP and its supporters recruit enthusiastic Coloradoans committed to agriculture and rural Colorado. They should be recognized as emerging leaders who are directly involved in agriculture, agribusiness, rural industries, rural communities or natural resource management.

ASSISTANCE FOR SMALL BUSINESSES AVAILABLE THROUGH THE CARES ACT

WHAT YOU NEED TO KNOW

- Small businesses (including farms) who have fewer than 500 employees are eligible for the program.
- The program is open until June 30, 2020. However, borrowers are advised to apply as soon as possible given the loan cap on the program.
- Small businesses and sole proprietors eligible to apply beginning April 3, 2020.
- Independent contractors and self-employed individuals eligible to apply beginning April 10, 2020.

CONSULT WITH YOUR ACCOUNTANT AND LENDER

You can apply through any existing SBA 7(a) lender or federally insured depository institution, federally insured credit union, or Farm Credit System participating in PPP. All lenders have been made SBA loan providers, but not all are participating. Consult with your local lender to see if they are participating.
